As more than 50% of the votes attaching to the Shares held by the Shareholders present and voting in person or by proxy at the AGM were cast in favour of each of the above ordinary resolutions numbered 1 to 5(C), such resolutions were duly passed as ordinary resolutions.

As at the date of the AGM, the total number of issued Shares of the Company was 400,000,000 Shares, which was the total number of Shares entitling the holders to attend and vote for or against each and every resolution. There were no Shares entitling the Shareholders to attend and abstain from voting in favour of any of the Proposed Resolutions as set out in Rule 13.40 of the Listing Rules. No shareholder was required under the Listing Rules to abstain from voting on the Proposed Resolutions. None of the Shareholders has stated his/her intention in the Circular to vote against the Proposed Resolutions or to abstain from voting at the AGM.

The Company's branch share registrar in Hong Kong, Tricor Investor Services Limited, was appointed as the scrutineer at the AGM for the purpose of vote-taking.

Final Dividend Payment

The proposal for the payment of a final dividend of HK2.7 cents per ordinary share for the year ended 31 December 2014 (the "**Dividend**") to the shareholders of the Company whose names appear on the register of members of the Company on 10 June 2015 was duly passed and approved at the AGM. The dividend warrants will be posted on or around 26 June 2015 by ordinary mail to the shareholders of the Company who are entitled to receive the Dividend at their own risk.
