### **DISCLOSEABLE TRANSACTION PROVISION OF FINANCIAL ASSISTANCE**

#### **PROVISION OF THE NEW LOAN**

The Board is pleased to announce that on 19 November 2021, GICL, as lender, entered into Loan Agreement E with the Customers, as borrowers, pursuant to which, GICL agreed to grant a secured loan in the amount of HK\$24,000,000 for a term of 24 months.

Prior to the entering into of Loan Agreement E, GICL, as lender, entered into the Previous Loan Agreements for the grant of four secured loans in an aggregate original principal amount of HK\$38,600,000 to the Customers (as the case may be). Upon the drawdown of the New Loan, one of the Previous Loan Agreements in the principal amount of HK\$14,000,000 is repaid.

The Group is principally engaged in money lending business of providing property mortgage loans and personal loans in Hong Kong under the Money Lenders Ordinance. GICL, as the lender of the New Loan and the Previous Loans, is an indirect wholly-owned subsidiary of the Company.

#### **LISTING RULES IMPLICATIONS**

As one of the applicable percentage ratios in respect of the New Loan exceeds 5% but all are less than 25% under Rule 14.07 of the Listing Rules, the grant of the New Loan constitutes a discloseable transaction for the Company under Chapter 14 of the Listing Rules.

As each Customer is associated with each other (details of their relationship are set out in the section headed "Information on the Customers" in this announcement), the grant of the New Loan requires aggregation with the Previous Loans under Rule 14.22 of the Listing Rules. As the applicable percentage ratios in respect of the New Loan and the Previous Loans in aggregate exceed 5% but all are less than 25% under Rule 14.07 of the Listing Rules, the grant of the New Loan and the Previous Loans constitutes a discloseable transaction for the Company under Chapter 14 of the Listing Rules.

## **PROVISION OF THE NEW LOAN**

The Board is pleased to announce that on 19 November 2021, GICL, as lender, entered into Loan Agreement E with the Customers, as borrowers, pursuant to which, GICL agreed to grant a secured loan in the amount of HK\$24,000,000 for a term of 24 months, details of which are set out as follows:

Part of the loan proceeds from Loan Agreement E are used to settle the principal amount under Loan Agreement B.

## **PROVISION OF THE PREVIOUS LOANS**

Prior to the entering into of Loan Agreement E, GICL, as lender, entered into the Previous Loan Agreements for the grant of four secured loans in an aggregate original principal amount of HK\$38,600,000 to the Customers (as the case may be). A summary of the Previous Loan Agreements is set out as follows:

## **INFORMATION ON THE CREDIT RISK RELATING TO THE NEW LOAN AND THE PREVIOUS LOANS**

The New Loan and the Previous Loans are collateralised against the first mortgages in respect of a retail shop, a residential property and a building comprising two retail shops and two residential units provided by the Customers with an aggregate loan-to-value ratio of approximately 66.2% based on the value of the mortgaged properties for the New Loan and the Previous Loans as determined by independent property valuers. Details of each of the mortgage and their respective loan-to-value ratio are summarized as below:

Loan Agreement A is collateralised against a first mortgage in respect of a residential property provided by Customer A with a loan-to-value ratio of approximately 65.3% based on the value of the mortgaged property as determined by an independent property valuer when the loan was originally assessed. The Group has been regularly monitoring the updated market value of the mortgaged property under Loan Agreement A and the Board considered that there is no adverse change to the loan-to-value ratio as at the date of this announcement.

Loan Agreement C and Loan Agreement D are collateralised against a first mortgage in respect of a retail shop provided by the Customer A and Customer B with a loan-to-value ratio of approximately 62.2% based on the value of the mortgaged property as determined by an independent property valuer.

Loan Agreement E is collateralised against a first mortgage in respect of a building comprising two retail shops and two residential units provided by Customer C with a loan-to-value ratio of approximately 70.6% based on the value of the mortgaged properties as determined by an independent property valuer.

The advances in respect of the New Loan and the Previous Loans were made based on (i) the Group's credit assessments on the financial strength and repayment ability of the Customers; and (ii) the collaterals provided by the Customers, which are at prime sites in Hong Kong. In assessing the financial strength and repayment ability of the Customers, the Group has (i) considered the value of the mortgaged properties; (ii) considered the historical repayment record of the Customers with no record of default as at the date of this announcement; (iii) reviewed the external credit reports and ratings of Customer A and Customer B, with satisfactory results; and (iv) conducted a litigation and bankruptcy search on the Customers with no material irregularities noted. After taking into account the factors as disclosed above in assessing the risk of the advances, the Group considers that the risk involved in the advances to the Customers is acceptable to the Group.

## **FUNDING OF THE NEW LOAN**

Part of the New Loan in the amount of HK\$14,000,000 is used to settle the outstanding principal under Loan Agreement B and the Group will finance the remaining New Loan of HK\$10,000,000 by the Group's general working capital.

## **INFORMATION ON THE CUSTOMERS**

### ***Customer A***

Customer A is an individual and an Independent Third Party. He is one of the directors and one of the ultimate beneficial owners of Customer C. He is a merchant and the spouse of Customer B.

### ***Customer B***

Customer B is an individual and an Independent Third Party. She is one of the directors and one of the ultimate beneficial owners of Customer C. She is a housewife and the spouse of Customer A.

### ***Customer C***

Customer C is a company incorporated in Hong Kong with limited liability which is principally engaged in the business of property holding and is an Independent Third Party. Each of Customer A and Customer B is (i) a director; and (ii) one of the ultimate beneficial owners of Customer C.

The Customers are repeated customers of the Group and their aggregate outstanding loan amount due to GICL, prior to the grant of the New Loan, was approximately HK\$38,478,000 and there is no record of default as at the date of this announcement. Customer A, Customer B and Customer C are the same borrowers under the respective loan agreements as disclosed in the Previous Announcements, who are defined as “Customer A”, “Customer B” and “Customer C”, respectively in the Previous Announcements. To the best of the knowledge, information and belief of the Directors having made all reasonable enquiry, the Customers and its ultimate beneficial owners (where applicable) are third parties independent of the Company and its connected persons.

## **INFORMATION ON THE GROUP AND GICL**

The Group is principally engaged in money lending business of providing property mortgage loans and personal loans in Hong Kong under the Money Lenders Ordinance. GICL, as the lender of the New Loan and the Previous Loans, is an indirect wholly-owned subsidiary of the Company.

## **REASONS FOR ENTERING INTO LOAN AGREEMENT E AND THE PREVIOUS LOAN AGREEMENTS**

Taking into account the principal business activities of the Group, the grant of the New Loan and the Previous Loans to the Customers is in the ordinary and usual course of business of the Group.

The terms of Loan Agreement E and the Previous Loan Agreements were negotiated on an arm's length basis between GICL and the Customers. The Directors consider that the grant of the New Loan and the Previous Loans is financial assistance provided by the Group within the meaning of the Listing Rules. The Directors are of the view that the terms of Loan Agreement E and the Previous Loan Agreements were entered into on normal commercial terms based on the Group's credit policy. Taking into account the satisfactory financial background of the Customers and that a stable revenue and cashflow stream from the interest income is expected, the Directors consider that the terms of Loan Agreement E and the Previous Loan Agreements are fair and reasonable and the entering into of Loan Agreement E and the Previous Loan Agreements is in the interests of the Company and its shareholders as a whole.
